#### Feedback from the cleaners:

Mary stated via email that she came in on Weds instead of Monday x2 weeks due to hurricane + snowstorm; she said she was glad people noticed the ring wasn't clean because the vacuum no longer works and asked if the board could be approached about purchasing a new one; she further emailed Sharon Morton to ask if the board could take a vote on a new vacuum, stating it doesn't pick up anymore.

Dawn requested feedback from Pat re: the vacuums (there are 2 in the office): Pat stated via email she uses the same one all the time, the second one doesnt sound right, and doesn't clean as well. She further stated, (as discussed last year), the attachment tools are insufficient; so when cleaning hard to reach places, she brings in her own Shopvac from home.

The board discussed the need for a new vacuum. There are already two vacuums; one works; the other should be looked at and/or taken to service for evaluation before being replaced.

Cleaning schedule was discussed and decided this is not fair and week 5 should be alternated between the cleaners.

Board discussed Pat Billings has spent extra time cleaning the ring and taking the initiative to bring her own shop vac in to clean the club.

Marianna proposed to honor her as Outstanding Member of the Year for her contributions.
